



Limitations of use, warning of misuse:

Garments must be worn outside of the trousers to maintain visualisation of maximum area of required high visibility. Garments must be worn fastened. Should the high visibility properties of garments become seriously impaired the item should be replaced.

Storage: Garments should be stored and transported in clean, dry conditions. DO NOT store in areas subject to direct sunlight.

Cleaning:



Machine wash at 40°C, do not bleach, do not dryclean, do not tumbledry, do not iron.

Maximum number of wash cycles 50.



Provides UVA + UVB protection from the sun. Sun exposure causes skin damage. Only covered areas are protected. The protection offered by this item may be reduced with use or if stretched or wet.
